#### Program Overview

Complex security issues continue to challenge our nation. The use or threatened use of weapons of mass destruction (WMD) remains a credible concern, one which exposes both our military and civilian citizens to changing, new, and possibly lethal dangers, as evidenced by events of September 11, 2001. This submission reflects a carefully balanced program focused on safeguarding America's interests from WMD (chemical, biological, radiological, nuclear, and high explosives) by controlling and reducing the threat and providing quality tools and services for the warfighter. Accordingly, resources have been programmed to support critical requirements across the spectrum of combat support, technology development, threat control, and threat reduction mission areas.

As WMD challenges continue to evolve and grow, DTRA has rebalanced its program and associated resources to fill the Department's highest priorities regarding the identification, reduction, defeat, and response to WMD. As part of this effort, emphasis was given to supporting the highest priority combat support requirements; providing capabilities to defeat and mitigate threats associated with chemical and biological weapons; simultaneously addressing threats from terrorist attacks; maintaining emphasis on nuclear issues relevant to traditional adversaries and emerging threats; supporting arms control and cooperative threat reduction programs having important interagency and international dimensions; furthering our transformation efforts; and addressing our infrastructure deficiencies.

The Nuclear Arms Control Technology Program and associated resources are transferred from the DTRA to the Army and Air Force. DTRA, the Army, and the Air Force have agreed to this transfer, with the basic seismic portion of the Nuclear Arms Control program being transferred to the U.S. Air Force; and the remainder of the Nuclear Arms Control program which includes the R&D program covering information fusion, test bed activities (Center for Monitoring Research activities) and sensor design, and associated O&M and Procurement funding being transferred to the U.S. Army Space and Missile Defense Command in Huntsville, Alabama. The Under Secretary of Defense (AT&L) has approved this transfer.

On 31 August, the Deputy Secretary of Defense reestablished Defense Technology Security Administration (DTSA). The FY 2002 - FY 2005 funding for the DTSA is not included in the DTRA budget. DTSA will be submitting their own Procurement, Defense-Wide budget.

#### Purpose and Scope of Work

To provide resources necessary to replace mission-essential vehicles in support of the DTRA programs and to replace overage and leased equipment or procure new investment items required to perform DTRA's assigned mission.

#### Justification of Funds

The procurement program provides for a vehicle program that will ensure uniform serviceability to all areas. The vehicle program requires the replacement of five (5) passenger-carrying vehicles in FY 2004 at a cost of \$200,000.

The procurement program also includes other major equipment at a cost of \$37,350,000. The largest portions of these funds are for the Advanced Unitary Penetrator and the Advanced Notice Advanced Concept Technology Development. Funding also provides for Plutonium Production Equipment and other operational equipment requirements to support the accomplishment of the DTRA mission.

The BLU-116A/B, Advanced Unitary Penetrator (AUP), is a penetrating 2000-pound air-to-surface warhead intended to provide improved penetrability for weapon systems that currently employ the BLU-109/B (AF) and BLU-109A/B (Navy) penetrating warheads. The AUP provides approximately twice the penetration capability of the BLU-109 in order to provide reliable kill for hard, buried targets containing WMD related facilities. Further, the AUP maintains the BLU-109 flight characteristics and aircraft interfaces to minimize flight certification requirements and to maintain compatibility with all guidance units and aircraft that now carry the BLU-109 penetrator. The AUP provides a near term capability for the warfighter to effectively target and minimize the collateral effects associated with counterforce operations against WMD related facilities. The AUP provides the target planner greater flexibility in selecting attack options that will achieve the required penetration and target kill while reducing the probability of undesirable collateral effects. The Naval Air Warfare Center - China Lake (NAWC-CL) is the integrator for this program, performing the final assembly. The first option has been exercised. In early FY 2003, AUP performance of the qualification units will be tested against concrete hardened targets using the GFE Hard Target Smart Fuze. The program is on-track to award the FY 2003 options early 2nd Qtr FY 2003. The FY 2003 total of 184 includes 17 Trainer (D-1) BLU-116A/B bombs.

Currently, the AUP warhead (BLU-116A/B) is only compatible with the Hard Target Smart Fuze (HTSF) fuze. The HTSF fuze program has experienced System Development and Demonstration (SDD) qualification problems & redesigns resulting in delaying SDDD completion and transition into production. Due to scrap and rework costs by the contractor, PPO1 and PPO2 have been combined to produce approximately 80 fuzes with deliveries in 4th Qtr FY 2003. CALCM will receive sufficient fuzes to meet their needs with the balance split 50/50 between Air Force and Navy. Due to these program delays and the need for AUP employment capability in the Central Command (CENTCOM) theater, \$3.174 million of the FY 2002 procurement funds were reallocated to the AUP production program from the HTSF production program to modify an existing FMU-143 fuze. The Navy intends to contract with Dayron, Inc. to modify the FMU-143 fuze, which is in production, to be compatible with the AUP warhead system and produce approximately 300 fuzes. This risk mitigation option provides the warfighter a limited precision weapon system employment capability against hardened, WMD related facilities until sufficient HTSF production fuzes are received by the Navy (estimate late FY 2004). Once sufficient HTSF fuzes are supplied to the Navy, the modified FMU-143 fuzes will be reassigned to other compatible Navy weapon systems.

The Hard Target Smart Fuze (HTSF) is intended to provide an operational fuze capability for penetrating weapons that permits optimization of the burst location for defeating WMD related facilities while minimizing collateral effects. The HTSF provides layer detection, void detection, and depth-of-burst capabilities in addition to time delay. This allows much more precise control over detonation location in order to increase lethality and limit collateral effects in attacking WMD targets. The HTSF provides the target planner greater flexibility in selecting attack options that will achieve the required weapon detonation location. By using the various modes of the HTSF, the warfighter can tailor the attack to pinpoint the detonation location thereby effectively defeating the target while controlling undesirable collateral effects. Following 9/11, the Conventional Air Launched Cruise Missile (CALCM) penetrator program was accelerated which also required an acceleration of the HTSF. Fifty reduced function HTSFs were built from SDD assets and fielded to the Air Force in support of CALCM. This acceleration delayed completion of SDD and subsequently delayed delivery of fully functional production fuzes. The HTSF fuze program has experienced SDD qualification problems & redesigns resulting in delaying SDD completion and transition into production. Due to scrap and rework costs by the contractor, PPO1 and PPO2 have been combined to produced approximately 80 fuzes with a deliveries in 4th Qtr, FY 2003. CALCM will receive sufficient fuzes to meet their needs with the balance split 50/50 between Air Force and Navy. Due to these program delays and the need for AUP employment capability in the CENTCOM theater, \$3.174 million of the FY 2002 procurement funds were reallocated to the AUP production program.

The Tactical FLIR Pod Modification, renamed Bomb Impact Assessment (BIA), is a modification of the standard Air Force LANTIRN Targeting Pod flown on the F-15E aircraft. This modification adds a solid state digital recorder and radiometers to the pod and a data cartridge interface and analysis program to the Weapon System Video Workstation. This will accelerate the post mission analysis of LANTIRN BIA Targeting Pod data and allow rapid insertion into the intelligence channels. The BIA provides a near term capability for the warfighter to effectively conduct bomb impact assessment of high priority Weapons of Mass Destruction (WMD) targets. This new enhanced capability will allow quick post-mission assessment of weapon performance target interaction (parameters such as in-soil vs void). In early FY 2001, the BIA went through a full Critical Design Review (CDR) and the first production contract for 4 units was awarded 2nd Qtr FY 2002. Delivery of these units will occur in 2nd Qtr FY 2003. Included in the FY 2001 production contract was delivery of 8 WSV-WV kits for digital editing of the BIA data (Radiometer Algorithm Program, Data Cartridge Interface and SCSI card). The second, and final, production option for 12 units will be a awarded in 2nd Qtr FY 2003 upon receipt of funds with deliveries in FY 2004.

Advanced Notice is an advanced concept technology demonstration (ACTD) intended to demonstrate enhanced capabilities for the customer, United States Special Operations Command (USSOCOM), to interdict WMD relted facilities while minimizing collateral effects. Advanced Notice integrates existing and developing technologies to produce special operation forces (SOF)

focused capabilities for counterprolifertion operations against biological warfare production, stoarage, and weaponization facilities. The objective is to provide to the Geographic Combatant Commanders/USSOCOM capabilities that are adaptable

to other areas of responsibilities (AORs), for counterproliferation activities in response to a country's biological weapon

(BW) program. The ACTD acts as a forcing function across the DoD to develop Joint Doctrine, focusing on SOF capabilities, for counterproliferation of biological warfare infrastructure not vulnerable to attack by conventional forces. The cost elements represent an end-to-end capability to counter the foreign bio threats. The demonstration takes place 3rd Qtr, FY 2003 and the ACTD begins to transition the residual technologies with demonstrated military utility in the 1st Qtr, FY 2004. The ACTD procurement or residuals and maintenance will conclude after FY 2005. Since the technologies are commercial off-the-shelf (COTS) items, recurring costs are not expected.

This funding also provides for the replacement of overage and leased or new investment items required to perform the mission of DTRA. Budget estimates also include costs associated with the new Defense Threat Reduction Center. These costs will provide a security system, server, switches, routers, audio/visual and operations center systems and other capital equipment to support ADP connectivity, and telephone systems.
