Subject: FY 2015 Department of the Navy (DoN) President's Budget (PB) Summary

1. Purpose. Provide a summary of the FY 2015 DoN President's Budget.

a. Budget Overview.

• The PB 2015 budget request reflects the FY 2015 portion of the Bipartisan Budget Agreement (BBA) and a FYDP profile to reach the Budget Control Act of 2011 (BCA) spending reductions by FY 2023. DoN funding is reduced when compared with PB 2014 primarily due to PB 2014 exceeding the BCA caps.


- Two DDG 51
- Three Littoral Combat Ships
- 470 new aircraft over the FYDP
 - o FY 2015 funds 103 airframes. Highlights include:
 - 8 F-35B/C, 4 E-2D, and 8 P-8A
 - 26 AH-1Z/UH-1Y, 19 MV-22, and 37 MH-60R/S
- Drawdown of Marine Corps manpower continues in FY 2015 toward the revised goal of 175,000 Marine Corps end strength by FY 2017
- Continued OCO-to-Base transfer
- Battle force ship count, reflecting revised counting rules to include forward deployed Patrol Craft and Hospital Ships, is 283 in FY 2015
- Ship depot maintenance funded to 80 percent in baseline funding
- Ship operations funded to support 45 underway days per quarter for deployed forces and 20 days per quarter for non-deployed forces in baseline funding
- Navy/Marine Corps flying hours budgeted at T-2.5/T-2.0 rating

d. Financial Stewardship


• The DoN continues to develop and expand the scope of its Business Transformation efforts. DoN business processes for acquiring services are being examined to look for ways to reduce costs in three areas: Contractual Services, Better Buying Power in Procurement, and More Efficient Uses of Research and Development. Additionally, the DoN continues to reduce unobligated growth across all programs, achieve savings in military construction bids due to increased competiveness, and reduce headquarters staffs.




