General Notes

- 1. For reporting purposes, all amounts are presented in USD. The conversion rate applied was the same as used by the United Nations to convert contracts denominated in EURO into USD.
- 2. United Nations OFFP records Refers to databases and records maintained by the United Nations, specifically, the Office of the Iraq Programme (OIP) and the United Nations Treasury Department.
- 3. SOMO surcharge records Refers to the State Oil Marketing Organization (SOMO) ledger of surcharges collected from September 2000 to March 2003.
- 4. <u>SOMO allocation records</u> Refers to Ministry of Oil lists of allocations for each phase approved by the Iraqi leadership, letters from the executive director of SOMO to the Minister of Oil seeking approval for allocations with handwritten approvals by the Minister of Oil, and Shamkhi H. Faraj report to the Minister of Oil, "Allocations and Sales of Crude Oil in the phases of the Memorandum of Understanding 1996-2003."

Column Descriptions:

- 1. Contracting Company The name of the actual or intended contracting entity. An "intended contracting entity" is one that, according to Ministry of Oil records, was allocated oil, but did not lift the oil. A contract between an "intended contracting entity" and SOMO is denoted hereinafter as an "intended contract." The source of the actual contracting entity names is the United Nations records, whereas the sources of the intended contracting entity are Ministry of Oil and SOMO records. The entities are listed in alphabetical order by their known legal name at the time that the information was compiled. Some of these entities are no longer active or have been dissolved; others are subsidiaries of other organizations. There are a total of 323 entities, 249 of which lifted oil and 74 of which were allocated oil but did not lift. (Source: Actual contracting entity-United Nations OFFP records; intended contracting entity-SOMO allocation records).
- 2. Mission Country The country, or countries, with which the purchaser registered to buy oil from Iraq under the Programme as designated in United Nations records. (Source: United Nations OFFP records).
- 3. Number of Contracts The number of the contracts to purchase oil entered into by an entity either as an actual or intended contracting entity. (Source: Actual contracting entity-United Nations OFFP records; intended contracting entity-SOMO allocation records).
- 4. Non-Contractual Beneficiaries for One or More Contracts An entity or individual, other than the named contracting party, that is identified in the Ministry of Oil records as the beneficiary of the oil allocation. (Source: SOMO allocation records).
- 5. Barrels Allocated The number of barrels of oil allocated to contracting entities as reflected in Ministry of Oil records. In total, some 4.5 billion barrels were allocated. (Source: SOMO allocation records).
- 6. <u>Barrels Lifted</u> The amount of barrels of oil lifted by the contracting entities as reflected in the United Nations records. In total, some 3.4 billion barrels were lifted by contracting entities under the Programme. (Source: United Nations OFFP records).
- 7. Contract Value The aggregate amount in USD expended by a contracting entity for the purchase of oil. For all contracts, this amount totaled \$64.2 billion. (Source: United Nations OFFP records).
- 8. <u>Surcharges Levied</u> The total amount of surcharges levied in USD on the contracts executed by a contracting entity. This information is based on Ministry of Oil records. The total amount of surcharges levied is \$263.3 million. (Source: SOMO allocation records).
- 9. Surcharges Paid The amount of surcharges paid in USD on the contracts executed by a contracting entity. This information is based on Ministry of Oil records and amounts to approximately \$228.8 million. (Source: SOMO allocation records).
- 10. Surcharges Outstanding The difference between surcharges levied and surcharges paid amounts to approximately \$34.5 million. (Source: SOMO allocation records).
- 11. Company Response Prior to the issuance of these tables, the Committee attempted to notify companies for which there was evidence of payment of a surcharge in connection with one or more of their contracts to invite any response or information. Company responses were classified into the following categories:
 - Category A: Company admits that it knowingly made illicit payments to the Government of Iraq or its agents.
 - Category B: Company denies that it made payments to the Government of Iraq or its agents in violation of the Programme.
 - Category C: Company acknowledges payments were made or may have been made, but denies knowing at the time that its agents or employees made illicit payments.
 - Category D: Company acknowledges that payments were made or may have been made, but contends that payment was made with the belief that it was authorized under the Programme or for actual services performed by legitimate private contractors.
 - Category E: Company acknowledges receipt of the Committee's letter and takes no position or has requested expressly that its response not be disclosed.
 - Category F: Company did not respond.
 - Category G: Company was not noticed by the Committee or subsequent information was identified and it was no longer appropriate to list the company.
