- The FBI announced August 1 that a man dubbed the "Flip-Flop Bandit" was arrested July 29 after robbing a bank in Pooler, Georgia, and multiple others in North Carolina, Tennessee, Oklahoma, and Arkansas. *WFMY 2 Greensboro* (See item 4)
- Northbound lanes of Interstate 75 in Bradenton, Florida, were closed for approximately 12 hours August 1 after a crash involving 2 semi-trucks and 3 other vehicles caused dozens of gallons of diesel to spill onto the highway. WTSP 10 St. Petersburg (See item 8)
- New York officials announced August 1 that a bypass was installed around a leaking sewage pipeline in Amsterdam the weekend of July 30 while crews work to replace the faulty pipes after approximately 500,000 gallons of sewage spilled into the North Chuctanunda Creek since July 25. *Albany Times Union* (See item 18)
- Dr. Web researchers discovered an Android trojan, dubbed Anrdoid.Spy.305 was plaguing 155 Android apps on the official Google Play Store and affecting over 2.8 million users in order to deliver ads to a user's device. *Softpedia* (See item <u>25</u>)

1. August 2, Chicago Pioneer Press; Chicago Tribune – (Illinois) Barrington Mobil station to pay \$20,000 for gasoline leak. The U.S. Environmental Protection Agency (EPA) and the Illinois Attorney General's office reached a \$20,000 settlement with Shri Balaji Inc., August 1 after an unknown amount of gas leaked from an underground tank at the company's Mobil gas station in Barrington, Illinois, in January and entered a nearby sanitary sewer system, contaminated soil and groundwater, and caused vapors to enter neighboring homes. As part of the settlement, Shri Balaji Inc. must submit a remediation plan to the Illinois EPA, as well as soil and groundwater sampling and monitoring tests.

2. August 1, U.S. Department of Labor – (Wisconsin) Wisconsin shipyard faces nearly \$1.4M in OSHA penalties for exposing workers to lead, and other hazards while retrofitting vessel. The Occupational Safety and Health Administration cited Fraser Shipyards Inc., with 19 willful and 10 serious violations, and placed the company in its Severe Violator Enforcement Program July 29 after complaints alleging unsafe working conditions prompted an inspection at the Superior, Wisconsin facility which revealed that the company overexposed workers to lead, failed to implement a lead compliance program, and failed to provide training on lead and asbestos hazards, among other violations. Proposed penalties total \$1,395,000.

3. August 1, U.S. Department of Labor – (Texas) OSHA fines KWS Manufacturing Co. for repeat, serious violations. The Occupational Safety and Health Administration cited KWS Manufacturing Co., with three repeat and two serious violations July 28 following February and March inspections at the Burleson, Texas facility which revealed that the company failed to install guards on the helicoid roll mill and lathes, failed to provide medical evaluations for employees, and failed to install safety latches on hooks, among other violations. Proposed penalties total \$49,500. Source:

Highway 99 in Merced County, California, was closed for several hours August 2 after a tour bus traveling from Mexico to Pasco, Washington crashed into a pole, killing five people and injuring five others.

- 7. August 2, Wisconsin State Journal (Wisconsin) Liquid asphalt spill closed highway for hours, Rock County Sheriff's office says. Highway 14 in Rock County, Wisconsin, was closed for about 5 hours August 1 after a semi-truck carrying nearly 3,000 gallons of liquid asphalt overturned and spilled its load on the highway. Traffic was rerouted while crews worked to clean up the spill.

- 8. August 2, WTSP 10 St. Petersburg (Florida) NB I-75 lanes in Bradenton reopen after multi-vehicle crash. Northbound lanes of Interstate 75 in Bradenton, Florida, were closed for approximately 12 hours August 1 while crews worked to repair the roadway after a multi-vehicle crash involving 2 semi-trucks and 3 other vehicles caused dozens of gallons of diesel to spill onto the highway.

- 9. August 1, KPTV 12 Portland/KPDX 49 Vancouver (Oregon) Grand Ronde man dies

Highway 22 in Grand Ronde, Oregon, was closed for approximately 4 hours August 1 following a two-vehicle collision that left one person dead and sent another to the hospital with non-life threatening injuries. 10. August 1, Arizona Republic— (Arizona) **DPS: I-10 east reopened after deadly wreck.** Interstate 10 near Tonopah, Arizona, was closed for several hours August 1 after a semi-truck struck and killed a pedestrian.

11. August 2, U.S. Department of Agriculture – (National) Michael Angelo's Gourmet Foods, Inc. recalls shrimp scampi and meat lasagna products due to misbranding and undeclared allergens. Michael Angelo's Gourmet Foods, Inc., expanded a previous recall August 1 to include an additional 1,452 pounds of its frozen shrimp scampi and meat lasagna products due to misbranding and undeclared chicken, egg, soy, or shrimp after the company received customer complaints stating that the shrimp scampi packages may contain a chicken piccata product and the meat lasagna packages may contain a shrimp scampi product due to a packaging error. There have been no confirmed reports of adverse reactions and the products were shipped to distributors in the southern U.S.

- 12. August 1, U.S. Food and Drug Administration (Iowa; Minnesota; Wisconsin)
 Allergen alert expansion: Kitchen Cravings Strawberry and Mixed Berry Parfaits with trace peanuts or almonds. Kwik Trip, Inc., expanded a previous recall July 29 to include additional lots of its Kitchen Cravings Strawberry and Mixed Berry Parfaits products due to undeclared traces of peanuts or almonds after the company's supplier, Azar Nut Company, recalled additional lots of the granola it supplied the firm due to undeclared peanuts or almonds. No illnesses have been reported and the products were sold at Kwik Trip retail locations in Minnesota, Wisconsin, and Iowa. Source: http://www.fda.gov/Safety/Recalls/ucm514279.htm
- 13. August 1, U.S. Department of Labor (Georgia) **OSHA** cites feed mill, contractors after dust explosion kills 1, injures 5. The Occupational Safety and Health Administration cited JCG Farms of Alabama LLC, A to J Electrical Services, and D. Sims Inc., with a total of 23 safety and health violations July 22 after a February incident where an explosion at the Georgia chicken feed mill killed 1 worker and injured 5 others, prompting an investigation at the Rockmart, Georgia facility which revealed the company exposed employees to fire and explosion hazards, failed to develop or implement an emergency action plan, and failed to properly train employees to recognize hazards, among other violations. Proposed penalties for all three

companies total \$112,600.

14. August 1, U.S. Department of Labor – (Texas) Houston tortilla factory faces \$106K in federal penalties for exposing employees to amputation, machine, fall and extreme heat hazards. The Occupational Safety and Health Administration cited La Espiga de Oro Inc., with 25 serious violations August 1 after the agency received a complaint of unsafe working conditions, prompting an investigation at the Houston facility which revealed that the company exposed workers to struck-by hazards, failed to protect workers from dangerous machinery, and exposed workers to electrical hazards, among other violations. Proposed penalties total \$106,700. Source:

15. August 1, U.S. Department of Labor – (West Virginia) OSHA cites Bradley, West Virginia, logging company for exposing workers to multiple hazards while felling trees at Raleigh County work site. The Occupational Safety and Health Administration cited Switchback Timber Inc., with 1 willful, 1 repeat, 13 serious, and 3 other-than-serious safety violations July 21 after a complaint alleging multiple safety hazards prompted an investigation at the Dorothy, West Virginia worksite which revealed that the company failed to provide leg and face protection, failed to ensure workers wore hardhats when outside machine cabs, and failed to ensure employees used seatbelts, among other violations. Proposed penalties total \$42,600. Source:

16. *July 30, Food Safety News* – (National) **Texas puts Blue Bell Creameries on a short leash; imposes fine.** The Texas Department of State Health Services announced July 30 that Blue Bell Creameries, L.P. agreed to pay an \$850,000 fine after a Listeria monocytogenes outbreak that hospitalized 10 people and killed 3 others from January 2010 – January 2015 was traced to 3 of the company's production plants in Texas, Oklahoma, and Alabama. As part of the agreement, Blue Bell must continue testing ingredients, is required to hold finished products from distribution until negative test results are returned, and must hire independent experts to assess its production plant, among other requirements.

17. August 1, Canon City Daily Record – (Colorado) Cotter reports 7,000-gallon leak on property's pipeline. Cotter Corp. officials announced August 1 that a hairline fracture in a water line at its Canon City, Colorado milling facility leaked approximately 7,000

gallons of water into the Sand Creek stream valley over a 48-hour period during the weekend of July 30. Officials do not believe contaminated water left the company's property.

August 1, Albany Times Union – (New York) **DEC: 500,000 gallons of sewage entered Mohawk tributary.** The New York State Department of Environmental Conservation (DEC) announced August 1 that a bypass was installed around a leaking sewage pipeline in Amsterdam, New York, the weekend of July 30 in order to redirect the city's sewage while crews work to replace the faulty pipes after approximately 500,000 gallons of sewage spilled into the North Chuctanunda Creek, which feeds into the Mohawk River, since July 25. The DEC urged all municipalities that draw from the Mohawk River to sufficiently treat their drinking water.

19. August 1, ABC News – (Florida) 10 additional Zika cases found in Florida outbreak; governor activates emergency response. Officials from the Florida Department of Health confirmed 10 more cases of locally contracted Zika virus in northern Miami August 1, prompting the governor to activate the emergency response team from the U.S. Centers for Disease Control and Prevention (CDC) to help stop the outbreak. Officials stated that of the 2,300 Florida residents tested for Zika virus, 372 have been confirmed to be infected with the virus.

- 20. August 1, NBC News (Montana) 'Roaring lion' fire burns 2K acres, evacuates 500 homes in Montana. Crews worked July 31 to contain the Roaring Lion Fire burning in Ravalli County, Montana, which has burned through 2,000 acres, destroyed several structures, forced the evacuation of 500 homes, and threatens an estimated 200 more. - 21. August 1, Associated Press; KTVB 7 Boise (Idaho) Pioneer Fire grows to 38,000 acres, drones interfere again. Approximately 1,300 firefighters reached 30 percent containment August 1 of the 38,072-acre Pioneer Fire burning near Idaho City, Idaho. State Highway 21 was closed from north of Idaho City to south of Lowman as a precaution.

The U.S. National Park Service reported that the observation deck at the Perry's Victory and International Peace Memorial in Put-in-Bay, Ohio, was closed August 1 for repairs after lightning damaged the control system for the tower's elevator July 31. Crews were working to assess the damage.

- 23. August 2, Softpedia (International) Windows flaw reveals Microsoft account passwords, VPN credentials. Researchers discovered an exploit affecting the way Microsoft Windows handles old authentication procedures for shared network resources where an attacker could embed a disguised link to a server message block (SMB) resource inside a Webpage or an email viewed via Outlook that sends the victim's login credentials to authenticate on the malicious actor's domain once the user accesses the link via Internet Explorer, Edge, or Outlook. The exploit gives the hacker access to the user's Microsoft username, virtual private network (VPN) credentials, or password, which is leaked as a NT LAN Manager (NTLM) hash.

- 24. August 1, Softpedia (International) Data of 200 million Yahoo users pops up for sale on the Dark Web. Yahoo is investigating a potential data breach after cyber-criminal Peace_of_Mind (Peace) published a listing on TheRealDeal Dark Web marketplace that reportedly offers data on over 200 million Yahoo users for 3 bitcoin, or approximately \$1,800, including usernames, MD5-hashed passwords, dates of birth for all users, and in some cases, backup email addresses, country of origin, and ZIP codes for U.S. users.

August 1, Softpedia – (International) **Trojan in 155 Google Play Android apps affects 2.8 million users.** Security researchers from Dr. Web discovered a new variant of the Android.Spy family trojan, dubbed Anrdoid.Spy.305 was plaguing 155 Android apps on the official Google Play Store and affecting over 2.8 million users by collecting data about the user's device, including the email address connected to their Google user account, the name of the app the trojan leverages for distribution, and the developer ID and software developer's kit (SDK) version, among other details in order to deliver ads. 26. August 1, SecurityWeek – (International) SSL flaw in Intel Crosswalk exposes apps to MitM attacks. Intel released updates for its Crosswalk framework after security researchers from Nightwatch Cybersecurity discovered a serious vulnerability in the Crosswalk Project library that allows malicious actors to launch man-in-the-middle (MitM) attacks and capture sensitive information transmitted by the app after finding that when a user makes a network request and accepts the initial error message displayed by the app if an invalid Secure Socket Layer (SSL) certificate is found, the app accepts all future SSL certificates without validation even when connections are made via different WiFi hotspots and different certificates.

Authorities are investigating the cause of a three-alarm fire at Grove Supply Inc., in Doylestown Township, Pennsylvania, August 1 that spread to multiple other businesses, burned through power lines, and prompted the closure of surrounding roads while crews worked to contain the blaze. Five people including three firefighters were transported to an area hospital for evaluation.
